

# ***The Charitable Fund-raising Businesses Act***

## **Instructions on Applying for a Charitable Fund-raising Business Licence**

To be licensed as a Charitable Fund-raising Business you will need:

- a) a registered name;
- b) an appropriate bond, and
- c) a completed application form.

### **1. Name registration:**

All corporations and operating (business) names must be registered with the Corporate Registry of the Information Services Corporation (ISC). Phone 306-787-2962 for information on this procedure.

### **2. Bonding requirements:**

After a review of the application, the registrar, taking into account campaign history of the fund-raising business and the public interest will determine the bond amount. Apply to your insurance agent or to any bonding company licensed under *The Saskatchewan Insurance Act* for a bond under *The Charitable Fund-raising Businesses Act*. See required penal bond wording attached.

The original bond is to be signed and sealed by the insurance company and signed by:

- o a Director (if a corporation)
- o all Partners (if a partnership)
- o an Individual (if a sole-proprietorship)

### **3.(a) Complete all pages of the application in full.**

There are two types of applications:

- o Application as a Charitable Fund-raising Business (4 pages)
- o Campaign Information

Please note, the **designated mailing address** (section 4 on the application) is used for mailing of correspondence from the Consumer Protection Division for routine correspondence, information, complaints and renewal notice.

The **Saskatchewan address for service** is the Saskatchewan address to be used for official notification of legal documents/actions.

### **3.(b) Notice required of all changes on the application**

Where any changes occur that affect or change the information on the application, written notice to Consumer Protection Division is required.

### **4. Licence fees are as follows:**

#### **Fund Raising Business \$600**

Make fee payable to the MINISTER OF FINANCE A form is enclosed if paying by credit card

**Once issued, a licence expires on the expiry date stated on the licence unless otherwise suspended or cancelled.**

5. **Mail** the following to this office:
- Completed application form(s) – with signatures.
  - Campaign information form at least **30 days before commencing any period of solicitation covered by a fund-raising agreement.**
  - Sample of the identification card carried by salespersons making door to door solicitation.
  - Two blank copies of your fund-raising agreement, if standardized.
  - Copy of the Agreement(s) from any fund-raising campaign(s) presently underway.
  - Licence fee(s) in the correct amount – see #4 above.
  - Original bond signed and sealed by bonding company along with the signature(s) of director(s) (if corporation); all partners (if partnership); or the owner (if sole-proprietorship).

### **6. General Remarks**

**The application information is to be legible or it will be returned.**

Every applicant for a licence should become familiar with the Act and Regulations. Also every applicant should exercise care in completing the application form. Extra care will avoid delays which occur when applications must be returned because of incomplete answers, incorrect fees.

**Prohibitions**

**45(1)** In this section:

(a) “**associate**” means, with respect to a relationship with a licensee, an officer or director of a licensee, or the spouse of an officer or director of a licensee, as the case may be:

- (i) a body corporate of which the licensee, officer, director or spouse beneficially owns, directly or indirectly, more than 10% of any class of voting equity securities of the body corporate that are outstanding at that time;
- (ii) a shareholder of the licensee;
- (iii) a partner, other than a limited partner, of the licensee, officer, director or spouse;
- (iv) a trust or estate in which the licensee, officer, director or spouse has a beneficial interest or serves as a trustee or in a capacity similar to that of a trustee;
- (v) any person who has the same residence as the licensee, officer, director or spouse; and
- (vi) a former spouse, child, sibling, half-sibling, parent, grandparent, uncle, aunt, nephew or niece of an officer, director or spouse, as the case may be, and where applicable, including step-family relationships;

(b) “**interest**” means ownership or financial interest in a charitable organization and includes:

- (i) an interest as a shareholder, member, director, officer or employee;
- (ii) a security interest; and
- (iii) any other interest that may give the holder of the interest influence over the conduct of the affairs of the charitable organization;

(c) “**spouse**” means the legally married spouse of a person, or a person with whom that person is cohabiting in a spousal relationship.

# Penal Bond Wording

## *The Charitable Fund-raising Businesses Act*

**PROVIDED** that if the Principal or Surety at any time gives notice in writing to the Registrar of *The Charitable Fund-raising Businesses Act* of intention to terminate the obligation hereby undertaken then this obligation shall cease and determine in respect only of any act, matter or thing taking place, arising or done subsequent to twenty-seven calendar months after receipt by the Registrar of such notice.

**PROVIDED FURTHER** that if such notice has been given, any claim hereunder shall be made on the Surety before the expiration of the aforesaid twenty-seven months.

**AND PROVIDED FURTHER** that no proceeds of this bond shall be paid to any person in respect of a contract entered three calendar months or more after receipt by the Registrar of any such notice.
