Payday Lender Annual Licence Renewal Instructions

Please read the instructions in their entirety before completing and submitting the application and any supporting materials. These instructions relate to the licence renewal application form, and set out the supporting information to be provided by an applicant requesting a payday lender licence renewal under *The Payday Loans Act*, (the "Act"). Also every applicant should exercise care in completing the application form. Extra care will avoid processing delays which occur when applications must be returned because of incomplete answers or incorrect fees.

This Renewal form is to be used for renewal of existing Saskatchewan payday lender licences. If you do not currently hold an active payday lender licence in Saskatchewan, please use the Payday Lender Licence Application Kit instead of this licence renewal kit.

Applicants are encouraged to submit the completed documentation **no later than one (1) month prior to the licence expiry date**. Lenders operating without a licence are subject to prosecution.

Renewal applications will be processed upon receipt of all required information and documentation. All lenders are required to complete the entire application. Please note that as part of the licence renewal process, the Director, Consumer Credit Division, (the "Director") may require the applicant to provide additional information.

A complete Licence Renewal Application will include ALL of the following items:

Licence Renewal Application form completed; statutory declaration signed and notarized
Annual licence fees (\$3,000 per licensed location)
Location Addendum completed for each licence for which a renewal is requested

Licence Renewal Form

The items correspond to the fields of the application form:

- 1. **Legal name of applicant**: please provide the complete legal name of the payday lender as evidenced in the articles of incorporation, partnership agreement, or any other similar legal document. Please ensure your registry information and filing is current.
- 2. **Operating Name**: if the payday lender will be operating using a business / trade / DBA (doing business as) name other than its legal name please include that name as you would like it to appear on your licence. All business names must be current with the Corporate Registry maintained by Information Services Corporation. Section 34 of the Act prohibits licensees from carrying on business under a name other than as set out on their licence.
- 3. **Contact Person:** Section 16 of the Act requires applicants and licensees to notify the Director in writing of certain changes. Please indicate name and title of the person responsible for monitoring and reporting changes in the information contained in the application.
- 4. **Head Office**: please provide the address for the head office of the applicant and associated contact information. All general correspondence will be sent to this address.
- 5. Address for Service: the address for service must be a location in Saskatchewan that maintains regular business hours and has staff available to receive documents. Typically this address would be one of the applicant's licensed business locations or a law firm in Saskatchewan. This address cannot be a post office box number. Section 6 of the Act requires every applicant to provide an address for service in Saskatchewan, and section 16 of the Act requires every licensee to immediately notify the Director in writing of a change to an address for service.

- 6. **Fees enclosed**: Pursuant to section 4 of the Regulations, an annual licence fee of \$3,000 per licensed location must be submitted for each licence; the Location Addendum form must be included for each location.
 - Section 14 of the Act establishes that a licence is valid for one year from the date of issuance. Refunds are not issued for any licenses cancelled or surrendered within the licence period.
 - Make all cheques payable to the Minister of Finance. A \$25 service charge will be applied for anycheque returned from your financial institution due to insufficient funds.
- 7. **Personal Disclosures**: Check the appropriate boxes. If you are unsure about the nature or result of any judicial, regulatory or administrative proceeding that impacts on the answer to a question, consult legal counsel. Any "Yes" answers must be accompanied by an explanation in detail as requested.
- 8. **Business Disclosures**: Check the appropriate boxes. If you are unsure about the nature or result of any judicial, regulatory or administrative proceeding that impacts on the answer to a question, consult legal counsel. Any "Yes" answers must be accompanied by an explanation in detail as requested.

Location Addendum

Section 5 of the Act requires a payday lender to obtain a separate licence for each location from which the payday lender will carry on business in Saskatchewan. In fulfillment of this requirement, applicants must attach to the application form a completed Location Addendum with respect to <u>each</u> location from which the applicant intends to carry on business as a payday lender in Saskatchewan. Licences will only be issued for a location specified in a Location Addendum.

If the applicant offers or arranges payday loans to borrowers located in Saskatchewan through the Internet, by fax, email or phone, the applicant must obtain a licence for the location from which the payday loans are offered or arranged. Payday loans are offered or arranged from the physical location at which the applicant's representatives who correspond or communicate with borrowers for the purposes of processing loan applications are located.

General Remarks

Every applicant for a licence should become familiar with the Act and the Regulations.
