Errors and Omissions Insurance

The Mortgage Brokerage and Mortgage Administrators Act requires all applicants for mortgage brokerage and mortgage administrator licenses to obtain errors and omissions insurance in a form approved by the Saskatchewan Superintendent of Financial Institutions (the “Superintendent”).
