## SPOUSE'S WAIVER OF DESIGNATED BENEFICIARY STATUS UNDER A POOLED RETIREMENT SAVINGS ACCOUNT CONTRACT

This waiver must be completed by the spouse of the owner ("owner") of a pooled retirement savings account contract ("the contract") where the spouse wishes to waive his or her designated beneficiary status under clause 16(10)(a) of *The Pooled Registered Pension Plan (Saskatchewan) Regulations*. The waiver must be completed before the death of the owner of the contract and filed with the issuer of the contract. The waiver may be revoked by the spouse at any time before the owner's death by providing written notice to the issuer of the contract.

By completing and signing this waiver, the spouse waives his or her entitlement to the funds in the contract on the death of the owner and allows the owner to designate a beneficiary of his or her choice. Prior to signing this waiver, the spouse should seek the advice of a lawyer and a qualified financial advisor.

Under The Pooled Registered Pension Plans (Saskatchewan) Act, "spouse" means:

- (a) a person who is married to a member; or
- (b) if a member is not married, a person with whom the member is cohabiting as spouses at the relevant time and who has been cohabiting continuously with the member as his or her spouse for at least one year prior to the relevant time.

The waiver must be:

- completed in its entirety;
- signed by the spouse, in the presence of a witness, outside of the immediate presence of the owner; and
- filed with the issuer of the contract.

If the owner transfers the funds in the contract to a contract issued by another financial institution, a copy of the completed waiver must be provided to that institution by the owner.

We strongly urge the spouse to seek independent legal advice before signing this waiver.
