**Order Setting Hearing Dates**

**WHEREAS**, pursuant to section 17 of *The Financial and Consumer Affairs Authority of Saskatchewan Act [FCAA Act]*, the Chairperson of the Financial and Consumer Affairs Authority of Saskatchewan (the "Authority") has appointed a panel (the "Hearing Panel") to hear this matter;

**AND WHEREAS**, by virtue of subsection 17(7) of the *FCAA Act*, a decision or action of the Hearing Panel in relation to this matter is a decision of the Authority;

**AND WHEREAS**, the hearing dates of March 2-6, 9-13 and 16-20, 2020 was previously set by the Hearing Panel in this matter;

**AND WHEREAS**, the hearing proceeded on March 2-6, 9-13 and 16-17, 2020;

**AND WHEREAS**, the Authority did on March 17, 2020 adjourn the hearing sine die;

**AND WHEREAS**, the hearing proceeded on October 30, 2020;

**AND WHEREAS**, the hearing proceeded on March 22,23,24,25 and April 8, 2021;

**AND WHEREAS**, the Hearing Panel released its decision concerning the merits on this matter on December 7, 2021;

**AND WHEREAS**, the sanctions and costs hearing proceeded on February 23, 2022;

**AND WHEREAS**, the Hearing Panel released its decision concerning the sanctions and costs on this matter on April 29, 2022;


Upon hearing the submissions of legal counsel for the Securities Division of the Financial and Consumer Affairs Authority of Saskatchewan and legal counsel for Jack Louis Comeau and Pinnacle Wealth Brokers Inc. concerning setting a date for the financial compensation hearing into the above noted matter;

**IT IS HEREBY ORDERED THAT:**

1. The financial compensation hearing into this matter shall commence at 9:00 a.m. (CST) on Monday, October 23, 2023 and continue thereafter, if necessary, on October 24 and 25, 2023, and/or such other dates and times as may be determined by the Hearing Panel;
2. In accordance with subsection 9(15) of *The Securities Act, 1988*, SS 1988-89, c S-42.2, should any party fail to attend the hearing on the date set forth above, the Hearing Panel may proceed with the hearing on that date in the absence of the party and make or give any decision as though that party were present;

3. This hearing will be held by way of a Virtual Hearing unless otherwise ordered by the Hearing Panel; and
4. Any party may raise preliminary matters with the Authority for its consideration, including said party's availability on the established hearing dates, by providing written notice of the matters or issues to be raised to the Registrar of the Authority.
