**EXTENDING ORDER**  
**(Section 134)**

WHEREAS the Saskatchewan Securities Commission (the "Commission") issued a temporary cease trade order on the 4th day of November, A.D. 1991 as amended on the 12th day of November, 1991 (the "Amended Temporary Order") pursuant to subsections 134(3) and 135(2) of The Securities Act, 1988, S.S. 1988, c. S-42.2 (the "Act"). The Amended Temporary Order is effective up to and including the 19th day of November, 1991. It provides that:

1. The Respondents, Aminika International Incorporated ("Aminkia"), 1st Provincial Development Fund Ltd. ("1st Provincial"), Myal West Marketing Ltd. ("Myal") and Dean Jersak, shall cease trading in any securities and commodity futures contracts;
2. The Respondent, Garry Woo, shall cease trading in any securities, and commodity futures contracts, provided that he may continue to trade in the securities of:

C.I.L. Paints Inc.  
Environmonde Products Inc.  
593706 Saskatchewan Ltd.  
593710 Saskatchewan Ltd.  
GarthLand Capital Fund Inc.  
Kuya International  
W. N. Tape Ltd.  
Woo Holdings Ltd.  
Woo Holdings Western Ltd.  
Woo Investments Inc. and

3. Trading in securities of Aminika, 1st Provincial and Myal shall cease;

AND WHEREAS some of the Respondents have requested that the Commission hold a hearing to determine whether the Amended Temporary Order should continue;

AND WHEREAS the Commission cannot hold a hearing before the Amended Temporary Order expires on November 19, 1991, but has scheduled a hearing to begin on December 12, 1991;

AND WHEREAS the Commission has not been provided with sufficient information to enable it to make an order under subsection 134(1) with respect to the Respondents by November 19, 1991;

THE COMMISSION HEREBY ORDERS, pursuant to subsection 134(3) of the Act, that the Amended Temporary Order is extended until the Commission completes its hearing into this matter or until further order.
