
C E A S E T R A D E O R D E R

WHEREAS on the 25th day of October, A. D. 1983 a Temporary Order was issued that trading in securities of Nova Village Limited Partnership should cease forthwith for a period of 15 days from the date hereof, pursuant to Section 151 of The Securities Act:

AND WHEREAS satisfactory information was not provided to the Commission within the 15 day period stated in that Order:

AND THEREFORE, the Commission being of the opinion that it is in the public interest that trading in securities of Nova Village Limited Partnership should cease; IT IS HEREBY ORDERED that the Temporary Order of October 25, 1983 be extended until such time as satisfactory information is provided to the Commission.
