CEASE TRADE ORDER (Subsection 134.1 (1))

WHEREAS Big Sky Finishers (No. 1) Inc., (the "Issuer") being a reporting issuer other than a mutual fund, within the meaning of *The Securities Act, 1988*, S.S. 1988, c. S-42.2 (the "Act"), has failed to file:

- 1. Comparative audited annual financial statements for the year ended June 30, 2011, as required by Part 4 of National Instrument 51-102 Continuous Disclosure Obligations.
- 2. Management's discussion and analysis materials for the annual period ending June 30, 2011, as required by Part 5 of National Instrument 51-102 Continuous Disclosure Obligations.
- 3. Annual certificates relating to the June 30, 2011 annual financial statements and management's discussion and analysis materials, signed by the chief executive officer and chief financial officer as required by National Instrument 52-109 Certification of Disclosure In Issuer's Annual And Interim Filings.

(The "Required Records");

NOW THEREFORE it is ordered under Subsection 134.1(2) of the Act, that all trading in the securities of the Issuer cease until the Issuer files the Required Records.
