## EXTENDING ORDER (Section 134)

WHEREAS the Saskatchewan Securities Commission (the "Commission") issued a temporary cease trade order on the 3rd day of January, A.D. 1991 (the "Temporary Order") pursuant to subsections 134(3) and 135(2) of <u>The Securities Act, 1988</u>, S.S. 1988, c. S-42.2 (the "Act") that:

- 1. Pioneer Development Company Limited, Citizen's Life and Casualty Insurance Company Limited, Church of God Houston, Our Father's Congregation, Melvin White and Jake Klassen (the "Respondents") shall cease trading in any securities up to and including the 18th day of January, 1991;
- 2. Trading in securities of Pioneer Development Company Limited ("Pioneer"), Citizen's Life and Casualty Insurance Company Limited ("Citizen's"), Church of God Houston ("Church of God"), and our Father's Congregation ("Our Father's") shall cease up to and including the 18th day of January, 1991;
- The exemptions contained in:
  - (a) sections 38, 39, 81, 82 and 102 of the Act; and

- (b) the regulations providing for exemptions from sections 27, 58 and 71 of the Act; and
- (c) any decision providing for exemptions from sections 27, 58, 71 or 104 to 109 of the Act;

do not apply to any trade in securities by the Respondents up to and including the 18th day of January, 1991.

AND WHEREAS the Commission has not received a request from the Respondents for a hearing pursuant to the terms of the Temporary Order;

AND WHEREAS the Commission has not been provided with sufficient information to enable it to make an order under subsection 134(1) with respect to the Respondents;

THE COMMISSION HEREBY ORDERS, pursuant to subsection 134(3) of the Act, that the Temporary Order be and is hereby extended until the Commission is provided with sufficient information to enable it to make an order under subsection 134(1) of the Act or until further ordered;
