TEMPORARY ORDER
(Sections 134 and 135)

WHEREAS it has been represented to the Saskatchewan Securities Commission (the "Commission") by the staff of the Commission that the securities of:

Canadian Newnorth Resources Limited
Freedom Rent-A-Car
Magic International Rammer Ventures Inc.
Majik Rent-A-Car (Canada) Inc.
Majik Rent-A-Car (U.S.A.) Inc.

(the "Companies") are and have been traded by Mervin Bodnarchuk ("Bodnarchuk") without Bodnarchuk having complied with the registration requirements contained in section 27 of The Securities Act, 1988, S.S. 1988, c. S-42.2 (the "Act") and without a prospectus having been filed and a receipt for such prospectus having been issued by the Commission with respect to a distribution of securities of the Companies as required pursuant to section 58 of the Act;

AND WHEREAS it has been represented to the Commission by the staff of the Commission that the securities of Magic International Rammer Ventures Inc. and Majik Rent-A-Car (Canada) Inc. are and have been traded by Brian Kirtzinger ("Kirtzinger") without Kirtzinger having complied with the registration requirements contained in section 27 of the Act and without a prospectus having been filed and a receipt for such prospectus having been issued by the Commission with respect to a distribution of securities of Magic International

Rammer Ventures Inc. and Majik Rent-A-Car (Canada) as required pursuant to section 58 of the Act;

AND WHEREAS the Commission is of the opinion that it is in the public interest to make this Order;

AND WHEREAS the Commission is of the opinion that the length of time required for a hearing would be prejudicial to the public interest;

THE COMMISSION HEREBY ORDERS pursuant to section 134(3) of the Act, that trading in the securities of the Companies cease forthwith up to and including the 16th day of July, 1992 and that Kirtzinger and Bodnarchuk cease trading in all securities and commodity futures contracts forthwith up to and including the 16th day of July, 1992.

AND TAKE NOTICE THAT:


1. This Order may be extended for such period as the Commission considers necessary where sufficient information to enable the Commission to make an order pursuant to subsection 134(1) is not provided to the Commission on or before the 16th day of July, 1992;
2. If any of the Companies, Kirtzinger or Bodnarchuk makes a request which is received by the Commission on or before the 16th day of July, 1992, they shall be granted a hearing before the Commission to be held at the offices of the Commission being:

3. The purpose of such hearing held at the request of any of the Companies, Kirtzinger or Bodnarchuk will be to consider whether it is in the public interest that a permanent cease trade order pursuant to subsection 134(1) of the Act and a permanent prohibition of statutory exemptions pursuant to subsection 135(1) of the Act be made with respect to any of the Companies, Kirtzinger or Bodnarchuk by reason of the breaches of the Act hereinbefore described and by reason of failing to provide the Commission with satisfactory information on or before the date of the hearing or any extension thereof by the Commission;

4. Any party to these proceedings may be represented by counsel of their choice at any such hearing before the Commission;
5. Upon failure of any party to attend any such hearing at the time and place set therefore, the hearing may proceed in the absence of such party and such party is not entitled to any further notice of the proceedings therein.
