**EXTENDING ORDER
(Section 134)**

WHEREAS the Saskatchewan Securities Commission (the "Commission") issued a Temporary Order dated August 9, 1999 (the "Temporary Order") pursuant to clause 134 (1)(d) of *The Securities Act, 1988, S.S. 1988, c. S-42.2* (the "Act") that trading in all securities by Robert J. Sziraki, Maxhart Group of Companies, L. P., Maxhart Investment Corporation, Maxhart Capital Management Limited, Maxhart First Financial Corporation, Maxhart Auto Group Limited, Maxhart Equities Group Limited, Maxhart Capital Corporation, Rodeo Drives Holding Corp., Dynamic Technologies Inc., Maxhart Equities Inc., RDH Equities Inc., (the "Parties") cease up to and including August 23, 1999 and that pursuant to clause 134(1)(a) of the Act that the exemptions contained in sections 38, 39, 39.1, 81, 82, and 102 of the Act and the exemptions contained in *The Securities Regulations, R.R.S., c.-42.2 Reg 1*, which provide for exemptions from the requirements of sections 27, 58, 71, or 104 to 109 of the Act, shall not apply forthwith up to and including August 23, 1999 with respect to any trade in securities by the Parties;

AND WHEREAS the Commission has not received a request from the Parties for a hearing pursuant to the terms of the Temporary Order;

AND WHEREAS the Commission has not been provided with satisfactory information with respect to

this matter;

THE COMMISSION HEREBY ORDERS pursuant to subsection 134(3) of the Act that the Temporary Order be and is hereby extended until November 30, 1999.
