ORDER (Section 134)

WHEREAS an application has been received by the Saskatchewan Securities Commission (the "Commission") from the staff of the Commission for an order (this "Order") pursuant to section 134 of *The Securities Act*, 1988, S.S. 1988, c. S-42.2 (the "Act") that Maurice Wilfred Roberge ("Roberge") do the following:

- 1. For a period of 7 years from the date of the issuance of this Order:
 - a. To cease trading in any and all securities and exchange contracts in Saskatchewan or with any resident of Saskatchewan personally or by any other means including, but not limited to, by means of any company, limited partnership, general partnership, association, joint venture or other entity of which he is a director, officer, promoter or control person as defined by the Act, except in his personal account through a registrant;
 - b. To resign any position that he holds as a director or officer of an issuer or registrant;
 - c. To not become or act as a director or officer of any issuer or registrant;
 - d. Not be employed directly by any issuer or registrant;
- 2. To pay an administrative penalty in the amount of \$5,000; and
- 3. To pay the costs of investigation in the amount of \$3,000.

AND WHEREAS Roberge and the Director (the "Director") of the Saskatchewan Securities Commission (the "Commission") have entered into an Agreement dated October 10, 2000, the original

of which is attached as Appendix "A" to the Order;

AND WHEREAS Roberge has consented to the issuance of the Order and has waived any right to a bearing or appeal:

hearing or appeal;

AND WHEREAS the Commission ratifies the Agreement;

AND WHEREAS the Commission is of the opinion that it is in the public interest to make this Order;

THE COMMISSION HEREBY ORDERS THAT ROBERGE:

1. For a period of 7 years from the date of the issuance of this Order:

a. Cease trading in any and all securities and exchange contracts in Saskatchewan or with any

resident of Saskatchewan personally or by any other means including, but not limited to, by means of any company, limited partnership, general partnership, association, joint venture or other entity of which he is a director, officer, promoter or control person as

defined by the Act, except in his personal account through a registrant;

b. Resign any position that he holds as a director or officer of an issuer or registrant;

c. Not become or act as a director or officer of any issuer or registrant;

d. Not be directly employed by any issuer or registrant;

2. Pay an administrative penalty in the amount of \$5,000; and

3. Pay the costs of investigation in the amount of \$3,000.
