CEASE TRADE ORDER

WHEREAS on the 17th day of February, 1983 a Temporary Order was issued that trading in securities by Donald W. Reed, Valarie A. Reed, Eleanor M. J. Gasparik, S. Graham Mackey and Aubrey I. Nobrega, with respect to Reed Communications Inc., Reed Vocational Resources Library Ltd., Reed Leisure Library Ltd., Reed Travel Library Ltd., Reed Medical Library Ltd. and Reed Adventure Library Ltd., should cease forthwith for a period of 15 days from the date hereof, pursuant to Section 151 of The Securities Act;

AND WHEREAS satisfactory information was not provided to the Commission within the 15 day period stated in that Order;

NOW THEREFORE, the Commission being of the opinion that it is in the public interest that trading

in securities by Donald W. Reed, Valarie A. Reed, Eleanor M. J. Gasparik, S. Graham Mackey and Aubrey I. Nobrega should cease with respect to Reed Communications Inc., Reed Vocational Resources Library Ltd., Reed Leisure Library Ltd., Reed Travel Library Ltd., Reed Medical Library Ltd. and Reed Adventure Library Ltd., it is hereby ordered that the Temporary Order of February 17, 1983 be extended until such time as satisfactory information is provided to the Commission.
