TEMPORARY ORDER  
(Section 134)

WHEREAS it has been represented to the Saskatchewan Securities Commission (the "Commission") by the staff of the Commission that securities of Rammer International Canada Inc. ("Rammer Canada") and Rammer International Inc. ("Rammer") are and have been traded by Mervin Bodnarchuk ("Bodnarchuk") without Bodnarchuk having complied with the registration requirements contained in section 27 of The Securities Act, 1988, S.S. 1983, c. S-42.2 (the "Act") and without a prospectus having been filed and a receipt for such prospectus having been issued by the Commission with respect to a distribution of securities by Rammer Canada and Rammer as required pursuant to section 58 of the Act;

AND WHEREAS the Commission is of the opinion that it is in the public interest to make this Order;

AND WHEREAS the Commission is of the opinion that the length of time required for a hearing could be prejudicial to the public interest;

THE COMMISSION HEREBY ORDERS pursuant to section 134(3) of the Act, that trading in the securities of Rammer Canada and Rammer cease forthwith up to and including the 19th day of April, 1990 and that Bodnarchuk cease trading in all securities forthwith up to and including the 19th day of April, 1990.

AND TAKE NOTICE THAT:

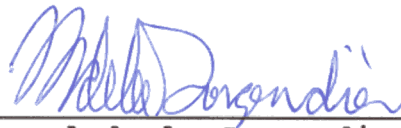
1. This order may be further extended for such period as the Commission considers necessary where sufficient information to enable the Commission to make an order pursuant to section 134(1) of the Act is not provided to the Commission on or before the 19th day of April, 1990.

2. If either Rammer Canada, Rammer or Bodnarchuk makes a request which is received by the Commission on or before the 19th day of April, 1990, they shall be granted a hearing before the Commission to be held at the offices of the Commission being:

3. The purpose of the hearing held at the request of Rammer Canada, Rammer or Bodnarchuk will be to consider whether it is in the public interest that a permanent cease trade order pursuant to section 134(1) of the Act be made in respect of the securities of the Rammer Canada and Rammer and in respect of Bodnarchuk by reason of their failure to comply with the registration and prospectus requirements of the Act;
4. Any party to the proceedings may be represented by counsel of his choice at any hearing held at the request of Rammer Canada, Rammer or Bodnarchuk;
5. Upon failure of any party to attend any hearing held at the request of Rammer Canada, Rammer or Bodnarchuk at the time scheduled for such hearing, the hearing may proceed in the absence of such party and such party shall not be entitled to any further notice in the proceedings.
