APPLICATION TO EXTEND A TEMPORARY ORDER

TAKE NOTICE that the Saskatchewan Financial Services Commission (the Commission) will hold a hearing at the 7th floor - 1919 Saskatchewan Drive, Regina, Saskatchewan on Thursday, March 25 at 9:00 AM:

TO CONSIDER WHETHER it is in the public interest to order that the temporary order of the Director of the Securities Division (the Director) issued pursuant to section 134 of *The Securities Act, 1988* (the Act) and dated March 16, 2010 (the Temporary Order) against Seisma Oil Research, LLC, Seisma Energy Research A.V.V., Seisma Energy Research, LLC, SXC Stock Exchange of the Caribbean A.V.V., Seisma McKenzie Drawn #1 Joint Venture also known as McKenzie Draw Joint Venture, Justin Solomon, Peter Somers and Victor Hedley (collectively the Respondents) be extended until September 30, 2010 or for such period of time as the Commission considers necessary.

BY REASON OF THE FOLLOWING MATTERS AND ALLEGATIONS:

1. The Director issued the Temporary Order ordering, among other things, that the exemptions in Saskatchewan securities laws do not apply to the Respondents and that the Respondents cease trading in all securities up to and including March 25, 2010;
2. The Temporary Order was issued without notice to the Respondents because the length of time to hold a hearing would be prejudicial to the public interest;


3. Commission staff are gathering further evidence related to this matter;
4. It is necessary to extend the Temporary Order until September 30, 2010 to complete the investigation and prepare a Notice of Hearing;

AND FURTHER TAKE NOTICE that a person or company attending or submitting evidence at the application may be represented by legal counsel of its choice.

AND FURTHER TAKE NOTICE that any party to the proceedings may, at the application, call witnesses and submit such evidence relevant to the hearing as it may wish;

AND FURTHER TAKE NOTICE THAT upon failure of the Respondents to attend at the time and place as aforesaid, the application will proceed in their absence and the Commission may make or give any decision or order as though that party were present.
