EXTENDING ORDER
(Section 151(2))


WHEREAS the Saskatchewan Securities Commission (the "Commission") by a Temporary Cease Trade Order dated July 29, 1988, ordered that trading in securities by Sunshine Orange Groves Inc., Trans-Globe Financial Corporation and Pacific Personnel Consulting Inc., (the "Issuers") should cease forthwith for a period of fifteen days from July 29, 1988, pursuant to section 151(2) of The Securities Act, R.S.S. 1978, C.S-42, (the "Act");

AND WHEREAS the Issuers have failed, within a fifteen day period from July 29, 1988, to request a hearing as provided for by the Temporary Order;

AND WHEREAS the Commission has not been provided with sufficient information to enable it to make an order under Section 151(1) of the Act with respect to the issuers;

IT IS HEREBY ORDERED, pursuant to Section 151(2) of the Act that the Temporary Order be and is hereby extended until the Commission is provided with sufficient information to enable it to make an order under Section 151 (1) of the Act or until further ordered.
