TEMPORARY CEASE TRADE ORDER
(Section 151)

WHEREAS the Saskatchewan Securities Commission (the "Commission") has received information indicating that securities of The Inter-Continental Equipment Group, Inter-Continental Equipment, Inc. Intermodal Container Equipment Ltd., ICE Marketing AG, Inter-Continental Equipment (Channel Islands) Ltd., ICE Offshore Container Services Ltd., and Inter-Continental Equipment Ltd. (the "Issuers") are being offered to the public in Saskatchewan by ICE Marketing AG and Craig Strang;

AND WHEREAS neither the Issuers nor Craig Strang are registered in any capacity under The Securities Act, R.S.S. 1978, C. S-42 (the "Act");

AND WHEREAS no prospectus or preliminary prospectus has been filed with the Commission, nor has any exemption order been granted by the Commission in respect of any trades in securities by the Issuers or Craig Strang;

AND WHEREAS the Commission is of the opinion that it is in the public interest to make this Order and that the length of time required for a hearing would be prejudicial to the public interest;

IT IS HEREBY ORDERED, pursuant to subsection 151(2) of the Act, that trading in securities of and by the Issuers and Craig Strang cease forthwith for a period of fifteen days from the date of this Order, which Order may be further extended for such period as the Commission considers necessary where sufficient information to enable the Commission to make an Order under subsection 151(1) of the Act is not provided to the Commission within the fifteen day period, provided that the Issuers and Craig Strang or any one or more of them, at its request to be received by the Commission within such fifteen day period, shall be granted a hearing (the "Hearing") before the Commission pursuant to section 151 of the Act and section 43 of the Regulations thereto within such fifteen day period or within such extended period of time as may be allowed by the Commission, such Hearing to be held at the offices of the Commission, being:

THE PURPOSE OF THE HEARING being to consider whether it is in the public interest that a permanent cease trade order pursuant to subsection 151(1) of the Act be made in respect of trades of securities of and by the Issuers and Craig Strang or any of them, subject to such terms and conditions and for such period of time as may be determined by the Commission, by reason of the Issuers and Craig Strang, or any of them, failing to comply with the registration and prospectus requirements of the Act with respect to trading in securities of the Issuers;


AND TAKE NOTICE that any party to the Hearing may be represented by counsel of his choice at the Hearing if he attends or submits evidence thereat;

AND TAKE NOTICE that upon failure of any party to attend at the Hearing, the Hearing may proceed in the absence of such party and such party is not entitled to any further notice of the proceedings.

AND FURTHER, the Commission orders that service of this Order and any subsequent order or decision of the Commission on the Issuers be as follows and such service shall be deemed to be sufficient for the purpose of the Act:

1. The Inter-Continental Equipment Group, Inter-Continental Equipment, Inc., Intermodal Container Equipment Ltd., ICE Marketing AG, Inter-Continental Equipment (Channel Islands) Ltd., ICE Offshore Container Services Ltd., Inter-Continental Container Equipment Ltd. and Craig Strang, by mailing a copy of any such Order to Arnold Bocklin-Strasse 29, CH-4011 Basel, Switzerland.
